For the year 2022-2024, Elections will be held for the following office bearers and elected members of the executive committee and hence nominations are invited for them.

1. Vice President (One Post)
2. Executive Committee members ( Two Posts)
3. Zonal Members ( Three Posts – One each from East, Central and North Zone)

## Eligibility

1. For the post of President, Vice-Presidents and Gen. Secretary, the candidate should have been elected and not nominated for 4 (four) years as follows;
  - i. On the National Executive Committee for a minimum of 2 (two) terms i. e. total 4 (four) years in the National Executive Committee or
  - ii. 1 (one) term of 2 (two) years in National Executive Committee and 2 (two) years as office bearer in the City Branch Executive Committee, the 2 terms not running concurrently.
  - iii. For re-eligibility to contest election for any post on the National Executive Committee the candidate must have attended at least 2(two) out of the last 4 (four) Executive Committee Meetings held in both years of his/her previous term. In case of such absence the member shall not be eligible to contest elections for one term (i.e. two years) and can contest after this period is over.
2. No member shall be eligible to seek election for more than 2 tenures each as Vice-President, Gen. Secretary, Treasurer, or Elected Member of the Executive Committee.
3. Candidates elected for post of vice president and above cannot contest for any post other than that of President. Any EC member cannot hold any post for more than 2 terms. (For the purpose of this clause, Executive committee Zonal members and Executive Committee members are treated as the same post.)
  - a. For all other positions other than President , Vice Presidents and Gen. Secretary, membership of the society for at least 5 years is mandatory( **as on 31<sup>st</sup> July 2022, i.e. membership on or before 31<sup>st</sup> July , 2017**)
  - b. The outgoing President cannot stand for any other post after his tenure, except for the post of Editor of the society Journal.

The nomination form (attached) must be completed with the candidate's name, address, AIDAA membership number and the office for which the candidate is nominated, proposed by one valid life member and seconded by another valid life member, and duly signed by the candidate, signifying his/her willingness to stand for the election and to serve on the Executive Committee if elected. There shall be a separate nomination form for each candidate, and for each post.

For every post, the nomination form must be accompanied by a sum of **Rs.10,000/-** (Rupees Ten thousand only) from a candidate, by electronic transfer
